Widows Expose Injustice, Demand National Policy

National Gender and Equality Commission rallies support for urgent legal and policy action to protect widows' rights in Kenya. A nationwide appeal to end the systemic marginalisation of widows gained momentum last week at the Kenya School of Government, where over 200 stakeholders gathered to spotlight the injustices faced by bereaved women across the country.

At the centre of the three-day high-level consultative forum was a call for urgent national policy and legal reforms to uphold the rights of widowed persons, particularly women. The event, convened by the Come Together Widows and Orphans Organisation (CTWOO), featured emotional testimonies from widows and firm commitments from public officials and civil society actors.

NGEC Joins GBV Hearings, Amplifies **Survivor Voices**



NGEC CEO, Dr. Purity Ngina MBS, at the ongoing county hearings by the Technical Working Group on GBV The Commission (NGEC), led by CEO Dr. Purity Ngina, has reaffirmed its commitment to listening, learning, and acting in the national fight against Gender-Based Violence (GBV).

This comes as the Commission actively participates in the ongoing county hearings by the Technical Working Group on GBV, appointed by President William Ruto on January 10, 2025.

42-member constituted to curb the escalating cases of GBV and femicide in Kenya, was mandated to examine, assess, and review the country's legal, policy, and institutional GBV, frameworks and recommend actionable strategies for reform.

The national public participation exercise kicked off on Monday, May 12, and will run until Wednesday, May 28, covering all 47 counties.

Dr. Ngina, representing NGEC in this critical process, has already visited Embu, Murang'a, Nyeri, Kiambu, and Mandera counties. At each stop, the sessions placed communities at the center, providing a safe platform for survivors, local leaders, and residents to voice their experiences, concerns, and proposed solutions.

"Real change begins with the people," emphasized Dr. Ngina. "We are here to listen to the lived realities of Kenyans and co-create sustainable, homegrown solutions to end GBV once and for all."

The hearings have revealed a strong public demand for coordinated action, increased awareness, and robust support systems. Survivors and community members are calling for strengthened legal mechanisms, survivor-centered services, localized interventions to address the root causes of GBV.

As the hearings continue across the country, NGEC remains steadfast in amplifying community voices and influencing policy outcomes that promote equality, justice, and dignity for all.

NGEC, Plan-Swiss Alliance **Launch GBV Fight in Isiolo**

NGEC and Plan International Kenya unveil GBV response project with Swiss support to protect Isiolo's most vulnerable

Isiolo — The Commission (NGEC), through its Isiolo Regional Office, has partnered with Plan International Kenya to launch a new Gender-Based Violence (GBV) Prevention and Response Project in the Horn of Africa. The initiative is funded by the Swiss Agency for Development Cooperation.

Commissioner Nzomo Mbithuka led the Commission's delegation to the official launch, which targets Burat and Ngaremara Wards in Isiolo County. The project aims to strengthen GBV prevention and response systems through a coordinated, multi-sectoral approach.

The launch was preceded by courtesy visits to the Office of the Governor, where the NGEC and partners, hosted by the County Secretary, discussed strategies to deepen cooperation, coordination, and partnerships for effective project delivery.

The event brought together high-level stakeholders, including the Plan International Kenya Country Director and the Regional Director for Africa's Development from the Swiss Development Cooperation, underscoring the importance of cross-sectoral collaboration.

Speaking as Chief Guest, Commissioner Mbithuka reaffirmed NGEC's commitment to offering technical support and advancing strategic partnerships to galvanize collective action against GBV in the region.

The project, designed to empower vulnerable communities in northern Kenya, is expected to bolster local GBV response mechanisms and promote inclusive engagement across government, civil society, and community actors.

protection of the widowed persons rights in Kenya

A nationwide call to end the systemic neglect and marginalization of widowed persons-particularly women-rang out at the Kenya School of Government last week, as the Commission (NGEC) led calls for urgent policy and legal reforms to protect the rights of

Speaking at a high-level consultative forum hosted by the Come Together Widows and Orphans Organisation (CTWOO), NGEC Chairperson Hon. Rehema Jaldesa described widowhood in Kenya as a "structural gender inequality crisis that has long been normalized and ignored." The three-day event brought together widows, lawmakers, human rights actors, and civil society stakeholders, marking a turning point in Kenya's approach to widowhood as a human rights and public policy concern.

"There are over five million widowed persons in Kenya today, yet they remain legally invisible," Jaldesa said in her keynote address. "The death of a spouse should not lead to the death of one's rights. Yet, for countless women, this is precisely what it becomes."

The Chairperson emphasized that widowhood must be recognized not only as a personal tragedy but as a national governance issue exacerbates poverty, inequality, gender-based violence.

She cited evidence from NGEC's field investigations, which reveal widespread disinheritance, forced evictions, and physical and sexual abuse, all of which go largely unpunished due to gaps in the current legal and policy framework.

Among the most pressing concerns highlighted at the forum were the nondomestication of the UN Resolution on Widowhood, the absence of widows in official classification marginalized groups, and loopholes that fail to protect women in uncodified or customary marriages. Participants also exposed troubling cases of chiefs demanding bribes or sexual favors before issuing succession letters, and discriminatory laws that strip widows of property rights upon remarriage-restrictions not applied to widowers.

These are not isolated cases," said Jaldesa, "They point to systemic failure. Cultural silence must not be used as a shield for legal injustice."

The Commission has now formally recommended the development of a National Policy on Widowhood, the -

amendment of the Law of Succession Act to explicitly protect widows' rights, and the creation of a national database of widowed persons to inform service delivery and policy planning.

The forum's communique also called for the inclusion of widows in land control boards and local governance structures, the establishment of a national helpline, and the creation of a widow protection fund. It further demanded access to legal aid and psychosocial support for widows, who often suffer in silence without redress.

The push for reform received backing from lawmakers and legal experts, including Hon. Dr. Otiende Amollo, who underscored the discriminatory application of succession laws and the urgent need for legal clarity on the rights of surviving spouses in non-formal unions.

In her closing remarks, the Chairperson issued a powerful reminder: "A country cannot claim to be equal and just while ignoring the plight of its widowed women. The time to act is now."

The Commission has committed to follow through with multi-agency engagements to push for institutional responses the to policy recommendations. If adopted, these reforms would mark a watershed moment for widowhood rights in Kenya, anchoring dignity, justice, and recognition within the broader national equality agenda.

NGEC Champions Care: Spotlight on Women and Childcare Workers

Multi-stakeholder forum spotlights urgent reforms for women in childcare amid policy gaps

Inclusive Investment Initiative Ignites Interest: NGEC Champions Access at Kisumu Roundtable

National Gender and Equality Commission spotlights critical barriers for persons with disabilities in Kenya's investment forums

Kisumu, The National Gender and **Equality** Commission (NGEC) Kisumu office joined the Governor's Lands Investment Roundtable, highlighting significant yet overlooked challenge within Kenya's investment environment: the urgent ensure need to inclusivity and accessibility for all investors, especially persons with disabilities (PWDs).

During the forum, NGEC presented compelling data that revealing while approximately 70% of investors expressed a clear preference for inclusive investment spaces, the practical realities of many event venues tell a different story. Persons with disabilities attending the roundtable encountered substantial barriers, including physical inaccessibility of the event premises and the absence of sign language interpreters. obstacles effectively excluded a sizeable and vital fully demographic from engaging in discussions and decision-making processes critical to Kenya's economic development.

The roundtable, hosted by the Kisumu County Governor's office, brought together key stakeholders from government, private sector investors, and community representatives. The primary agenda was to foster a conducive environment for sustainable investment and land utilisation in the region. However, NGEC's intervention introduced a fresh and crucial perspective by underscoring

inclusivity as an indispensable element for equitable growth.

"Accessibility is not merely a legal obligation but a cornerstone of economic empowerment," remarked NGEC Kisumu regional head, Mr. Davis Okeyo. "Excluding persons with disabilities from investment forums undermines the broader goals of national development and equality. We call upon event organisers and policymakers to prioritise inclusive infrastructure and communication tools to foster true participation."



Despite existing legislation mandating accessibility standards in public and private spaces, enforcement remains inconsistent, particularly in the business and investment sectors.

The Kisumu County Government committed to reviewing venue selection policies to ensure compliance with accessibility guidelines and to engage sign language interpretation services at all official forums.

The NGEC's participation in the Governor's Lands & Investment Roundtable marks a pioneering step towards bridging the gap between Kenya's economic ambitions and the reality of equal opportunity. The Commission's call to action serves as a timely reminder that sustainable development must embrace diversity and accessibility as foundational pillars.
